ARTICLE I

The name of the Corporation shall be **THE BARRICKMAN GROUP, INC.**

ARTICLE II

The purposes of the Corporation are to establish, operate and maintain an organization that will preserve the history and natural beauty of Barrickman Lane farm properties, the scenic US Highway 42 corridor and Oldham County, Kentucky for the benefit, education and inspiration of future generations. To do all things necessary and useful in accomplishing the purposes set forth. Activities range from but are not limited to:

inform, educate and organize the public to impact attitudes and governmental policies toward the end of creating neighborhood plans, supporting sustainability, preserving neighborhood culture and environment and insuring appropriate neighborhood development. Other civil and social welfare activity consistent with the above purposes.

ARTICLE III

The duration of the Corporation shall be perpetual.
