**ARTICLE IV – NONPROFIT STATUS**This corporation is a nonprofit organization and shall not engage in any activity for profit. No part of the corporation's net earnings shall inure to the benefit of any private shareholder or individual. The corporation shall not participate in or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

**ARTICLE V – DURATION**The duration of this corporation shall be perpetual unless dissolved in accordance with the laws of the Commonwealth of Kentucky.

**ARTICLE VI – BOARD OF DIRECTORS**The corporation shall be managed by a Board of Directors. The number, qualifications, terms of office, and duties of the directors shall be established in the Bylaws of the corporation.

**ARTICLE VII – INCORPORATOR**The name and address of the incorporator of this corporation are as follows: Thomas Smith 250 W. Main St., #3150, Lexington, KY.

**ARTICLE IX – DISSOLUTION**Upon the dissolution of the corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or to the federal government, or to a state or local government, for a public purpose.

**ARTICLE X – AMENDMENTS**These Articles of Incorporation may be amended in the manner prescribed by the corporation's Bylaws and the laws of the Commonwealth of Kentucky.
