# FILING INSTRUCTIONS ARTICLES OF DISSOLUTION

## NAME

### **EVENT OF DISSOLUTION**

KRS 275.315 requires the articles of dissolution to set forth a statement of the subsection of KRS 275.285 pursuant to which the limited liability company has dissolved

## **DISSOLUTION DATE**

Articles of dissolution shall be filed after the dissolution of the limited liability company. The date of dissolution is when the event of dissolution occurred. A dissolution date that is in the future will not be accepted for filing.

## **ADDITIONAL INFORMATION**

Use this section to include any relevant information, including a delayed effective date for the articles of dissolution—not to exceed 90 days from the day delivered to the Secretary of State for filing pursuant to KRS 14A.2-070(2).
