GATEWAY RELIEF AND DEVELOPMENT SERVICES, INCORPORATED

Articles of Incorporation as Non-Profit Corporation

ARTICLE I: Name

The name of the corporation shall be: Gateway Relief and Development Services, Incorporated (hereinafter called GRADS).

ARTICLE II: Purpose

1. GRADS is organized exclusively for charitable purposes within the meaning of section 501(c)3 of the Internal Revenue Code to meet humanitarian needs arising from any form of disaster and to mitigate general human development needs such as resulting from developmental disabilities and injuries.
2. Notwithstanding any other provisions of these articles, GRADS shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by an organization, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE III: Agent/Registered Office

The name of the registered agent of GRADS is Richard Anane.

The initial registered office of GRADS is 10405 Venado Drive, Louisville, KY 40291.

ARTICLE IV: Mailing Address

The mailing address of GRADS is 6608 Hollow Tree Road, Louisville, KY 40228.

ARTICLE V: Directors

ARTICLE VII: Dissolution

Upon the winding up and dissolution of GRADS, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for humanitarian purposes.
