ARTICLES OF INCORPORATION OF

The undersigned acting as the incorporator of the within corporation, organized and formed as a corporation under and by virtue of the laws of the Commonwealth of Kentucky and specifically Chapter 271 B of the Kentucky Revised Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the within corporation shall be **Kentucky News Publications INC.**

<u>ARTICLE II</u>

The purpose for which the corporation is formed is the transaction of any and all lawful business for which corporations may be incorporated under Chapter 271 B of the Kentucky Revised Statutes.

ARTICLE III

The aggregate number of shares of capital stock, which the corporation shall have authority to issue, is a total of one thousand (1,000) shares of common stock, divided common stock of shares Duane James four hundred {400} shares/ Emelye Ball- six hundred {600} shares all of which are to be without par value. All shares of common stock shall have full and unlimited voting power, and each share shall be entitled to one (1) vote.

ARTICLE IV

The shareholders of the corporation shall have the preemptive right to acquire un issued or treasury stocks of the corporation or securities of the corporation convertible into or carrying a right to subscribed to or acquires such shares.

ARTICLE V

The corporation herein created may entered into contracts or transact business with one or more of its directors, officers, or stockholders, or with any corporation, association, organization or to the entity in which any one or more of its directors, officers or stockholders, have an interest or are otherwise interested; and, in the absence of fraud, no such contract or transaction shall be invalidated, void, avoidable or in any other way affected

by the fact that such directors, officers or stockholders of the corporation have, or may have, interest which are or might be, adverse to the interest of the corporation even tough the vote or action of such directors, officers, or stockholders having said adverse interest may have been necessary to the transaction. At any meeting of the Board of Directors of the corporation which shall authorize or ratify any such contract or transaction, any such director may vote or act thereat with like force and effect as if he/she said not have such adverse interest, provided, that in such case, the nature and extent of such interest shall be disclosed or shall have been previously known to the non-interested directors. In the absence of fraud, no director, officer or stockholder having such adverse interest shall be liable to the corporation or any shareholder or creditor thereof or to any other person, for any loss incurred by the corporation under or by reason of such contract or transaction, nor shall any such director, officer or stockholder be accountable for any gains or profits realized thereon.

ARTICLE VI

The name and address of the initial registered office of the corporation shall be DUANE JAMES 430 West Main St. Morehead, KY 40351; and the name of the initial registered agent for process of service at that address shall be Duane James Pres.

ARTICLE VII

The number of directors consisting the initial Board of Directors shall be two (2) and the name and address of the person who is to serve as director until the first annual meeting of the shareholders, or until successors are elected and shall qualify are: DUANE JAMES, Pres.
