ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapters 14A and 275, respectively, of the Kentucky Revised Statutes, and for the express purpose of amending the Articles of Organization of The Blake Hayden Group, LLC (the “Company”), a Kentucky limited liability company, the said Company, by and through its members, hereby submits the following, to-wit:

(1) The name of the Company presently on record with the Secretary of State of the Commonwealth of Kentucky is The Blake Hayden Group, LLC, as reflected in the Company’s Articles of Organization, the original of which having been filed with the said Secretary of State on February 7, 2020.

(2) The Company hereby amends its Articles of Organization as follows:

ARTICLE I

The name of the limited liability company shall be BHG Realty, LLC (the “Company”).

In all other respects, and except as expressly amended in ¶ (2), *supra*, the Company’s Articles of Organization otherwise shall remain in full force and effect.

(3) The foregoing Amendment duly was adopted on May 7, 2023, unanimously by the members of the Company in accordance with, and pursuant to, the Company’s Articles of Organization and the Company’s written Operating Agreement.

(4) The foregoing Amendment shall be effective on and as of the date of filing of this Amendment to Articles of Organization with the Secretary of State of the Commonwealth of Kentucky.

(5) This Amendment to Articles of Organization is executed by all the members of the Company, viz. Blakely C. Hayden and Melissa M. Hayden.
