

Articles of Organization
of

The undersigned hereby forms and organizes a professional limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Articles of Organization of such professional limited liability company:

Article I

The name of the professional limited liability company is:

William O. Flowers II PLLC

Article II

The name and street address of the registered agent is:

Article III

The mailing address of the initial principal place of business of the professional limited liability company is:

Article IV

The management of the professional limited liability company is reserved to managers elected and/or appointed in accordance with the operating agreement of the professional limited liability company. Only those elected or appointed as managers may bind the professional limited liability company, and no member, by reason of being a member, may bind the professional limited liability company. The authority of the managers shall be exercised in accordance with the operating agreement of the professional limited liability company.

Article V

The duration of the professional limited liability company shall be perpetual, save and until its dissolution in accordance with the Kentucky Limited Liability Company Act and the operating agreement of the professional limited liability company.

Article VI

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the professional limited liability company shall be personally liable for the debts, obligations,

or liabilities of the professional limited liability company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the professional limited liability company.

Article VII

The professional limited liability company has been formed to render the professional services of an attorney. No person not licensed to render this professional service, even if a member or manager of the professional limited liability company, shall in any way take part in or advise with respect to the rendering of care to a client or customer seeking professional services from the professional limited liability company and its licensed professionals.
