

**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby organizes a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act (the "Act") and adopts the following Articles of Organization of such limited liability company:

**ARTICLE I**

**NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability is Trail town Tickets and Travel, LLC (the "Company").

**ARTICLE II**

**INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

The Company has one or more members.

## ARTICLE VI

### MANAGEMENT

The Company's management is reserved to its members.

## ARTICLE VII

### DURATION OF COMPANY

Unless earlier dissolved in accordance with the Act and the Company's operating agreement, the Company shall have a perpetual duration from the effective date of the Company's Articles of Organization.

## ARTICLE VIII

### LIMITATION OF LIABILITY

Except otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.


