

**ARTICLES OF ORGANIZATION
OF

The undersigned organizer, **Donald B. White** of 430 Highland Heights, Hindman, Kentucky 41822, being more than 21 of age, does hereby execute for the purpose of forming and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky pursuant to KRS Chapter 275 and adopt the following **ARTICLES OF ORGANIZATION** for the purpose of forming a limited liability company under the laws of the Commonwealth of Kentucky, the undersigned does hereby submit the following Article of Organization to the Secretary of State for filing.

ARTICLE I

The name of the limited liability company shall be **NEW TRIBES FARMS L.L.C.**

ARTICLE II

The limited liability company shall have the purpose of buying, selling, leasing and renting property, equipment, and other goods as required for the function of **NEW TRIBES FARMS L.L.C.** And shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs including but not limited to those powers set forth in KRS 275.010.

ARTICLE III

The limited liability company shall be of perpetual duration.

ARTICLE IV

ARTICLE VI

ARTICLE VII

The management of the limited liability company shall be by its manager,
Donald B. White.

ARTICLE VIII

The personal liability of a member or a manager to the limited liability company or its members for monetary damages for breach of his duties as a member or a manager is eliminated to the fullest extent allowable under the provisions of KRS 275.180(1).

Further any member shall be indemnified for judgments, settlements, penalties, fines or expenses incurred in proceeding where a member is a party because he is a member or manager to the fullest extent allowed by KRS 275.180(2).
