Article I: The name of the nonprofit corporation is

Article II: The purpose of the nonprofit corporation is **Life Christian Academy Inc. is organized and will be operated as a school providing a Christian school option for any family in our local community who is interested in their child having an education that has a Christian emphasis. Life Christian Academy Inc. is newly formed and is still in the planning stages. We will start our first school year this fall for the 2024-2025 school year. Once operational, we will meet Monday through Friday from 8:00am to 3:00pm for classes and formal instruction. Life Christian Academy will enroll students in Kindergarten through the 8th grade. We may expand to high school age in the future. We will also provide a pre-school program for our families for children ages 3 and 4.
