The undersigned, LOGAN FEAGIN, of 565 Beech Grove Road, Mayfield, KY 42066, does hereby execute these Articles of Organization for the purpose of forming, and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

ARTICLE I: NAME

ARTICLE II: INITIAL PRINCIPAL OFFICE
