**ARTICLES OF ORGANIZATION
OF
KENTUCKY PERIODONTICS AND IMPLANT DENTISTRY, PLLC**

The undersigned hereby organizes a Kentucky limited liability company pursuant to the Kentucky Professional Limited Liability Company Act (the "Act") and adopts the following Articles of Organization of such limited liability company:

ARTICLE I

NAME OF LIMITED LIABILITY COMPANY

The name of the professional limited liability company is Kentucky Periodontics and Implant Dentistry, PLLC (the "Company").

ARTICLE II
