**ARTICLES OF INCORPORATION  
OF  
HOLE LOTTA LOVE DONUTS, INC.  
A KENTUCKY CORPORATION**

The undersigned Incorporator desires to form a corporation under the laws of the Commonwealth of Kentucky by delivering in duplicate to the Secretary of State of the Commonwealth of Kentucky these Articles of Incorporation, in accordance with the provisions of Kentucky Business Corporation Act (Act).

**ARTICLE ONE  
NAME**

The name of the Corporation is Hole Lotta Love Donuts, Inc.

**ARTICLE TWO  
DURATION**

The Corporation's duration is perpetual.

**ARTICLE THREE  
PURPOSES**

The Corporation is formed to engage in any lawful business permitted under the laws of the Commonwealth of Kentucky, and to do anything corporations are permitted to do under provisions of KRS § 271B.3-010 of the Act, as amended from time to time.

**ARTICLE FOUR  
SHARES**

The total number of shares of stock that the Corporation has authority to issue will be 1000 shares of Common Stock with no par value.

**ARTICLE FIVE  
REGISTERED OFFICE AND AGENT**

The Corporation's initial Registered Office address in the Commonwealth of Kentucky is: 6655 Rineyville Big Springs Road, Rineyville, KY 40162. The name of the Corporation's initial Registered Agent at that office is: **James Brannon Dupree**.

**ARTICLE SIX  
PRINCIPAL OFFICE ADDRESS**

The place in this state where the principal office of the corporation is to be located is 328 N. Mulberry Street, Elizabethtown, Kentucky 42701

**ARTICLE SEVEN  
BOARD OF DIRECTORS**

The business of the corporation shall be managed by a Board of Directors, the number and qualifications of the members of which shall be fixed by, or in the manner provided in, the Bylaws.

**ARTICLE EIGHT  
LIMITATIONS ON DIRECTOR LIABILITY**

Section 1. No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for any breach of his or her duties as a director, except for liability (i) for any transaction in which the director's personal financial interest is in conflict with the financial interest of the corporation or its shareholders and which is not a transaction permitted by the Kentucky Business Corporation Act in effect at the time of the transaction; (ii) for acts or omission not in good faith or which involve intentional misconduct or are known to the director to be a violation of law; (iii) for any vote for or assent to a unlawful distribution to shareholders as prohibited under KRS § 271B.8-330; or (iv) for any transaction from which the director derived an improper personal benefit.


Section 2. If the Kentucky Business Corporation Act is amended after the filing of these Articles of Incorporation to authorize corporate action further eliminating or limiting the personal liability of the directors, then the liability of a director of the corporation shall be eliminated or limited to the fullest extent permitted by the Kentucky Business Corporation Act, as so amended, and without the necessity for further shareholder action in respect thereof.

Section 3. Any release or modification of this Article by the shareholders of the corporation shall not adversely affect any right or protection of a director of the corporation hereunder which is given, provided or permitted by the Kentucky Business Corporation Act in effect at the time of the act or omission or in respect of any act or omission occurring prior to the time of such repeal or modification.
