## KENTUCKY ARTICLES OF ORGANIZATION OF A LIMITED LIABILITY COMPANY

Pursuant to the provision of the Kentucky Revised Statutes, KRS 14A and KRS 275, the und adopts the following articles of organization for **MUK ELECTRONICS LLC**.

- 1. The name of the limited liability company is **MUK ELECTRONICS LLC**.

- 10. This application will be effective upon filing.
