ORDINANCE NO. 91-A-9

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN REAL PROPERTIES INTO THE CORPORATE LIMITS OF THE CITY OF ADAIRVILLE, LOGAN COUNTY, KENTUCKY.

BE IT ORDAINED BY THE CITY OF ADAIRVILLE, KENTUCKY, THAT THE FOLLOWING SHALL BE ENACTED INTO LAW.

WHEREAS, by Ordinance No. 91- A-6, and dated the 8th day of August, 1991, the City of Adairville, Logan County, Kentucky, declared its intent to annex the territory described herein, and

WHEREAS, the ordinance of intent was published according to law on the 12th day of August , 1991, and

WHEREAS, more than sixty (60) days have elapsed since the enactment and publication of that Ordinance, and

WHEREAS, no petition has been received by the Mayor requesting an election on the proposed annexation pursuant to KRS 81A.420, now, therefore,

The City Council of Adairville, Logan County, Kentucky, does

hereby ordain as follows:

1. The following described territory is hereby annexed into the City of Adairville, Logan County, Kentucky, and henceforth for all purposes, it is part of the City of Adairville, Logan County, Kentucky, to-wit:


