ORDINANCE NO. 9, SERIES 2008

AN ORDINANCE CLOSING PUBLIC WAY – JOHNSON AVENUE

WHEREAS, the City of Anchorage has determined that a portion of the public way consisting of such of the right of way of Johnson Avenue (now Glenbrook Road) as shown on the plat of Bellevue Park Subdivision dated December 5, 1919, and recorded in Plat and Subdivision Book 2, Page 280, in the Office of the Clerk of Jefferson County, Kentucky, as lies at the southeast corner of Block 7, Lot 4, Bellevue Park, east of the easterly line of Johnson Avenue extended to the south and north of the center line of Parkway extended to the west ;

WHEREAS, the City finds as the following facts in support of such closing:

1. The above described right of way lies entirely within the City;
2. All of the property owners in or abutting the right of way are: Lawrence Scott Clark and Angela M. Clark and James T. Miller and Cynthia Miller;
3. Written notice of the proposed closing of the public way was given to all of the property owners; and
4. All of the property owners have given their written consent to the closing, duly notarized, which consents are attached hereto.

NOW, THEREFORE, be it ordained by the City of Anchorage that the public way consisting of such of the right of way of Johnson Avenue as lies at the southeast corner of Block 7, Lot 4, Bellevue Park, east of the easterly line of Johnson Avenue extended to the south and north of the center line of Parkway extended to the west shall be and it hereby is closed as a public way.

This ordinance shall be effective upon its passage and publication as required by law.




CONSENT OF OWNER TO CLOSING OF GLENBROOK ROAD
