ORDINANCE NO. 55, 1987

AN ORDINANCE OF THE CITY OF ASHLAND, KENTUCKY,
ANNEXING THE CERTAIN UNINCORPORATED TERRITORY
IN BOYD COUNTY ADJOINING THE PRESENT BOUNDARY
LINE OF THE CITY, BEING THAT AREA GENERALLY
BOUNDED BY 55TH STREET AND WOODLAND TERRACE.

WHEREAS, the City by Ordinance 22, 1987 and pursuant to KRS 81A.420 expressed its intent to annex the property described on Exhibit "A", and

WHEREAS, the City published the requisite notice of its intent to annex the property described on Exhibit "A" pursuant to KRS 424.130 and KRS 424.140, and

WHEREAS, more than sixty (60) days have passed and no petition has been received by the Mayor from the resident voters or owners of real property within the limits of the territory proposed to be annexed, and all other requirements of KRS 81A.420 and other applicable Statutes have been complied with,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ASHLAND,
KENTUCKY, AS FOLLOWS:

SECTION 1. The Board of Commissioners of the City of Ashland hereby annexes that certain territory within Boyd County adjoining the present boundary line of the City, being that area generally bounded by 55th Street and Woodland Terrace and extends the present boundary line of the City of Ashland to include such territory. The description and a map of the territory are attached hereto and made a part hereof by reference as if set out in full. The specific description appears on Exhibit "A". The map is marked Exhibit "B" for identification.


SECTION 2. The Board of Commissioners has determined that this territory is desirable for annexation. The territory is adjacent or contiguous to the city's boundaries and by reason of population density is urban in character.

SECTION 3. Upon the enactment of the Ordinance, the territory shall become a part of the City for all purposes.

SECTION 4. This Ordinance shall be in full force and effect from and after its adoption, readoption and publication, as required by law.

Beginning at a point in the existing southeasterly corporation line of the City of Ashland, said point being N 66° 15' E 2,200 feet more or less from the center line of KY 168; thence with the existing corporation line of the City of Ashland N 66° 15' E 600 feet more or less to a point; thence leaving said corporation line S 33° 53' 11" E 1,310 feet more or less to a point on the southerly side of 55th Street; thence with the southerly side of 55th Street S 36° 00' W 600 feet more or less to a iron pin on the south side of 55th Street; thence leaving the south side of 55th Street S 2° 26' W passing through an iron pin at 114.07 feet total distance 309.07 feet to an iron pin; thence N 68° 35' W 300.00 feet to an iron pin; thence N 70° 23' W 1.04 feet to a point; thence N 69° 42' W 98.96 feet to an iron pin; thence N 69° 46' W 46.01 feet to a point; thence N 65° 49' W 97.35 feet to a point; thence N 49° 40' W 48.21 feet to a point; thence N 28° 32' W 45.37 feet to a point; thence N 14° 10' W 50.18 feet to a point; thence N 10° 06' W 85.42 feet to a point in the south side of 55th Street; thence crossing 55th Street N 14° 38' 41" W 1,277.72 feet more or less to the point and place of beginning.

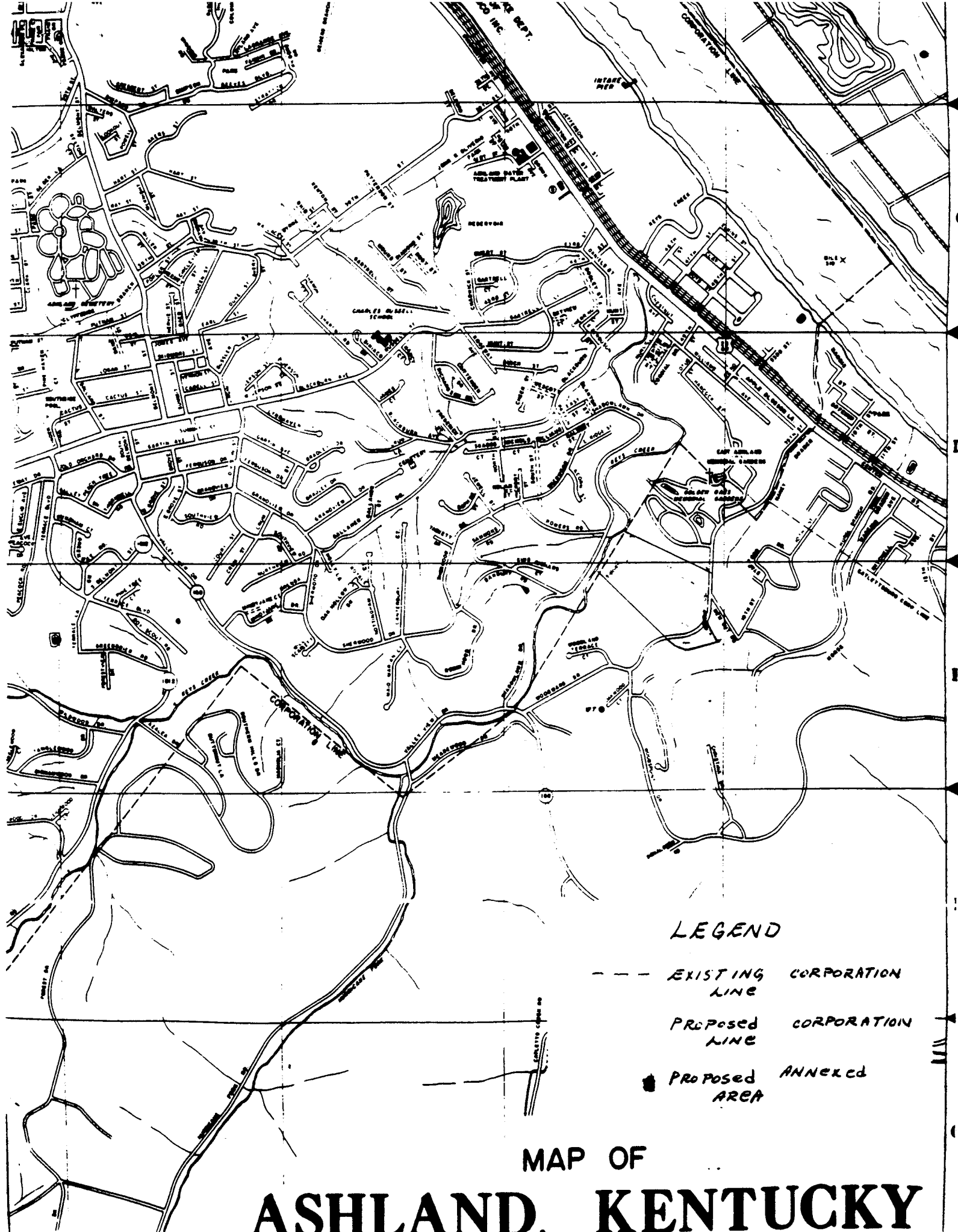
