


CERTIFICATION OF ORDINANCE NO. 1998-11

PRIOR CONSENT FOR ANNEXATION

ORDINANCE NO. 1998-11

WHEREAS, Larry G. Cain and Dorothy Cain are owners, in fee simple, of certain real property located in Knox County Kentucky; said real property being more particularly described as follows:

Beginning on a concrete marker corner to Tremco Property, in the City Limits line; said maker being on the southeast R.O.W. line of Tremco Road, Thence with the said R.O.W line and City Limits. 
