## BARBOURVILLE CITY COUNCIL REGULAR MEETING JUNE 6, 1996

The Barbourville City Council met in a regular meeting on June 6, 1996 at 7:00 p.m.

Members present: Bert Scent, James Thompson, Scott Smith and Clavin Manis.

Members absent: David Miller and Doug Hicks.

The meeting was called to order by Mayor Phillip E. Connley.

A motion was made by Bert Scent Second by James Thompson to approve the Minutes of May 9, 1996 regular meeting as presented. Motion Carried.

A motion was made by James Thompson second by Calvin Manis to approve the second reading and passage of Ordinance # 1996-3. An Ordinance adopting the City of Barbourville, Kentucky annual Budget for the fiscal year 7/1/96 to 6/30/97. Motion carried.

Jim Tye, Administrative Director reported that he had been notified that there will be an increase in the Health Insurance coverage of \$18,000.00 per year effective 7/1/96. Mr. Tye further stated he has attempted to contact the Anne Blair Insurance Agency for a quote for the self-insurance Health Care.

Councilman Thompson requested Jim Tye contact the Barbourville Water & Electric Commission about the possibility of joining their self-insurance group.

The Mayor stated the Budget will be amended if and when it is necessary to cover the increase in Health Care.

City Attorney, Greg Lathram reported that he has distributed a survey to merchants on the Court Square concerning the Parking problems. Mr. Lathram stated he wanted to do the survey before an Ordinance was drafted. The survey shows that the majority of the businesses wants no limits, but a designated parking area for County employees. Jurors will follow the same proceedure of a card on the dashboard of their car which will allow them to park during their time in court. Another problem discussed was the vehicle operators ignoring the pedestrian right of way at crosswalks.

Mr. Lathram suggested a committee be formed to work in conjunction with the County Officials and Business owners to research and study the problems and make suggestions to the Parking Authority before an Ordinance is written.

A motion was made by Scott Smith second by Bert Scent to approve the prior Consent for Annexation for the Gatliff Coal Company property, the Kentucky Virginia Stone Company property on the Artemus Road and the Malcolm Martin and Effie Fisher property on US 25E. Motion Carried.
