


CERTIFICATION OF ORDINANCE NO. 1998-10

PRIOR CONSENT FOR ANNEXATION  
ORDINANCE NO. 1998-10

WHEREAS, Larry Young and his wife, Helen Young, are owners, in fee simple, of certain real property located in Knox County, Kentucky; said property being more particularly located on KY 225 and Old Pineville Road South of Barbourville, Kentucky, and,

WHEREAS, Larry Young and his wife, Helen Young, declare that the aforesaid real property recorded on Page 43, of deed book 5 more particularly described as beginning at the forks of the road opposite the entrance to the Barbourville Cemetery; thence with the road leading from Barbourville to Artemus (sic) to a set stone in the edge of the road and in a line 10 feet from the rear of the building on said lot; thence a northeastward course and running 10 feet south of the rear end of the building to a set stone in the south side of the Fighting Creek Road, U.S. 25E Highway; thence a northwest course with said highway to the Beginning (shown as tract 1).

Beginning on the corner of J.H. Rose property line, running a southeast direction with Dixie Highway, 67 feet within six feet of the Masonic Hall Building; thence a southwest course of the Hall six feet to the back of the hall to a stone; thence a southeast course to the Arthur Adams line; thence a west direction to a line within 16 feet of Fuson line; thence with said lane a northwest course to the Artemus Highway; thence a northern direction to the Beginning ( shown as Tract 2). Being the same property transferred to them from the National City Bank of Kentucky on the 5<sup>th</sup> day of August, 1998, and

WHEREAS, Larry Young and his wife Helen Young, declare that the aforesaid real property presently is contiguous to or immediately adjacent to the corporate limits of the City of Barbourville, Kentucky, and,

WHEREAS, Larry Young and his wife Helen Young, declare that the aforesaid real property, by reason of its present commercial use, is urban in character and suitable for development for urban purposes without unreasonable delay;

NOW, THEREFORE, Larry Young and his wife Helen Young request that the aforesaid real property be annexed and included in the corporate limits of the City of Barbourville, Kentucky, pursuant to the provisions of KRS 81A.412.
