WHEREAS, Ordinance Number 1995-2 was enacted on April 6, 1995 by the Barbourville City Council; and,

WHEREAS, said ordinance was "an ordinance stating an intention to annex certain unincorporated territory contiguous to the City of Barbourville"; and,

WHEREAS, in order to prepare an accurate and complete map of the boundaries of the City of Barbourville it has become necessary to now adopt an ordinance carrying out the stated intention in the said Ordinance Number 1995-2 to complete the annexation of the territory as described in the foresaid ordinance (see Exhibit 1); and,

WHEREAS, more than sixty days have elapsed since Ordinance Number 1995-2 went into effect, and no petition containing signatures of property owners in the area to be annexed has been received by the Mayor pursuant to KRS 81A.420.

NOW THEREFORE, be it ordained by the *City Council of the City of Barbourville* that the territory described in Ordinance Number 1995-2 be, and it is hereby annexed to, and incorporated in, the territorial boundaries of the *City of Barbourville*.

FURTHER, the new and accurate legal description (see Exhibit 2) of the annexed territory is incorporated herein by reference to the said Ordinance Number 1995-2 as if fully copied at length.



PRIOR CONSENT FOR ANNEXATION

Said point being a southwest corner of the City of Barbourville's Sewer Pump Station property; thence leaving the centerline of Whitesburg Branch, continuing with the City of Barbourville's Sewer Pump Station property, N. 56 degrees 57 minutes E. 58.78 feet to an 18 inch tree; thence N. 50 degrees 16 minutes W., partway with a fence, 121.52 feet to a point in the centerline of Whitesburg Branch; thence leaving the City of Barbourville's Sewer Pump Station property, continuing with the
