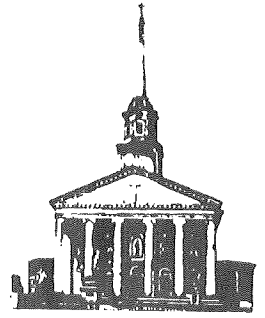

AN ORDINANCE ANNEXING TO THE CITY OF BARDSTOWN, KENTUCKY, A CERTAIN TRACT OF LAND IN NELSON COUNTY, KENTUCKY, BEING NEAR THE SOUTHERN LIMITS OF THE PRESENT BOUNDARY LINES OF SAID CITY.

WHEREAS, the City Council has expressed its desire and intent to annex certain unincorporated territory located in Nelson County, Kentucky, herein called the "Annexation Area" to the City; and

WHEREAS, the owners, in fee simple, through a written document, have pursuant to KRS 81A.500, requested annexation by the City of the unincorporated "Annexation Area", which is more fully described below;

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF BARDSTOWN, KENTUCKY:

The present boundaries of the City of Bardstown, Kentucky, are hereby extended to include within said city a certain tract of land located near the southeast limits of the City of Bardstown, the boundaries of which is defined and described as follows:


Beginning at a point in the northern right of way line of Kentucky Highway #49, said point being a corner with the Old Kentucky Home property and the former G.H. Padgett property recently purchased by State Parks, and thence proceeding with the existing City limit line and running across Kentucky Highway #49 along said property line S 26 degrees 40' E for a distance of 65 feet to a point; thence continuing along said property line S 26 degrees 40' E for a distance of 167 feet to a point, corner to Will Smith; thence turning and striking a new City limit line running along said property of Smith S 63 degrees 00' W for a distance of approximately 437 feet to a point in the southern right of way line of Kentucky Highway #49; thence turning and crossing Kentucky Highway #49 N 37 degrees W 60.2 feet to a point in the existing City limit line, said point being in the division line between State Parks and Kentucky Highway #49; thence running along curved radius of said right of way line for a distance of approximately 484 feet to the point of beginning containing an area of 64,899 square feet, more or less.

This ordinance shall take effect from and after its passage and publication as required by law.
