ORDINANCE NO. <u>B2008-02</u>

AN ORDINANCE AMENDING THE LEGAL DESCRIPTION IN THE ORDINANCE ANNEXING INTO THE CITY OF BARDSTOWN LAND LOCATED ON THE EAST SIDE OF THE BLUEGRASS PARKWAY, NORTH OF US HIGHWAY 150, AND SOUTH OF KENTUCKY HIGHWAY 605, EAST OF BARDSTOWN IN NELSON COUNTY, KENTUCKY CONTAINING APPROXIMATELY 400.00 +/- ACRES.

WHEREAS, in order to correct errors in the legal description the City Council does adopt the recitals and its findings of fact contained in Ordinance No. B2007-26 and ordains that the legal description in Ordinance No. B2007-26 be amended as follows:

I.The territory described below, a map of which is attached to this ordinance as Exhibit A and is fully incorporated into this ordinance, is hereby annexed into the City of Bardstown:

- IV. This Ordinance is adopted pursuant to KRS 83A.060 and said Ordinance shall be in full force and effect upon the signature, recordation, and publication in accordance with KRS 83A.060 and KRS Chapter 424.
