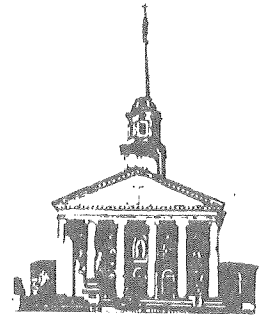

**ORDINANCE ANNEXING CERTAIN REAL ESTATE TO THE CITY OF BARDSTOWN**

WHEREAS, heretofore an ordinance was passed by the City Council of the City of Bardstown, Kentucky, found in Minute Book 16, page 238, at a meeting held on November 11, 1988, proposing to annex certain real estate to the City of Bardstown, which lands are hereinafter described, and

WHEREAS, said ordinance was given the required two readings and was published as required by law on December 5, 1988, and 60 days have passed after the enactment and publication of said ordinance, and

WHEREAS, no petition has been received by the Mayor in opposition to the proposal to annex within the 60 day period following publication.

NOW THEREFORE, the Board of Council of the City of Bardstown, Kentucky does ordain as follows:

That the territory hereinafter described be and the same is hereby annexed to the City of Bardstown and made a part of the City of Bardstown and placed within the corporate limits of the said City of Bardstown and the property so annexed is bounded and described as follows:


Beginning at a point in the existing City Limit line approximately 200 ft. North of the intersection of US Highway 31-E and John Rowan Boulevard, said point being in the East Right-of-Way line of Highway 31-E; thence proceeding with the existing City Limit line, and crossing Highway 31-E and passing through the lands of Kentucky Home Village N 73 degrees 04' W 1337 ft.; thence running with the division line between the City of Bardstown and Kentucky Home Village, and crossing KY 245 S 21 degrees 54' W 376 ft. to the front Northwest corner of Kentucky Home Square; thence with the South Right-of-way line of KY 245 N 73 degrees 51' W 280 ft.; thence, striking a new City Limit line crossing KY 245 and following the division line of BIDC and the West Right-of-way line of Kelly Drive, said line running parallel to and 30 ft. west of the center line of Kelly Drive, N 18 degrees 48' E 206.85 ft. thence N 22 degrees 26' E 51.34 ft.; thence N 24 degrees 04' E 68.05 feet; thence N 25 degrees 55' E 694.79 feet to the corner of BIDC and Jideco of Bardstown; thence continuing with said R/W line and the division line of Jideco of Bardstown N 25 degrees 23' E 102.0 feet to a stake; thence N 16 degrees 33' E 784.62 feet to a stake; thence continuing along the division line between Jideco and Kelly Drive and crossing Withrow Court Drive N 17 degrees 18' E 437.18 feet to a stake in the division line of the City of Bardstown and the North Right-of-way line of Withrow Court Drive; thence, following the City of Bardstown and Withrow Ct. N 76 degrees 28' W 862 feet to the division line of The City of Bardstown and Bird and Son; thence running in said division line N 12 degrees 10' E 1664 feet to a steel post in a fence which is the corner of Bird & Son, Hagan and City of Bardstown, running in the division line of Hagan and City of Bardstown S 76 degrees 20' E 1195.82 ft.; thence striking a line through the lands of Hagan and crossing Highway 31-E, S 76 degrees 20' E 510.0 feet to a point in the East Right-of-way line of Highway 31-E; thence, running along the East Right-of-way line of Highway 31-E S 2 degrees 45' W, 3725 feet to the point of the beginning, being approximately 134 acres.

This ordinance shall be in full force and effect upon its final passage and publication as required by law.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of said conflict.
