ORDINANCE ANNEXING CERTAIN REAL ESTATE TO THE CITY OF BARDSTOWN, KENTUCKY

WHEREAS heretofore an ordinance was passed by the City Council of the City of Bardstown, Kentucky found in Minute Book

15, page 198 at a meeting on Nov.22, 1982, proposing to annex certain real estate to the City of Bardstown, which lands are hereinafter described and,

WHEREAS said ordinance was given the required two readings and was published as required by law on 12-20-82 and 60 days have passed after the enactment and publication of said ordinance and,

WHEREAS no petition has been received by the Mayor in opposition to the proposal to annex within the 60 day period following publication.

NOW THEREFORE, the Board of Council of the City of Bardstown, Kentucky does ordain as follows:

That the territory hereinafter described be and the same is hereby annexed to the City of Bardstown and made a part of the City of Bardstown and placed within the corporate limits of the said City of Bardstown and the property so annexed is bounded and described as follows:

Beginning at a point approximately 1000 feet from West Stephen Foster Avenue on the western line of Barton Road said point being on the southwest corner of the existing City limit line on Barton Road; thence proceeding with the existing City limit line and the rear line of lots on southern side of South Kennett Avenue N 53 degrees W 825 feet to east line of S. Elm Grove Avenue, thence with S. Elm Grove S 14 degrees W 173.8 feet to corner, thence with the south line of Kurtz street N 76 degrees W approximately 100 feet, thence S 14 degrees 45' W 370 feet, thence S $\,$ 77 degrees 45' E 151.4 feet, thence S 13degrees 45' 143 feet, thence S 77 degrees 30' E 211.8 to iron post corner with Barton Brands Ltd., thence striking a new City limit line running with Barton's line and Pine Village Subdivision S 78 degrees 28' E 253.2 feet to west line of Barton Road, thence proceeding along west side of Barton main service road S 26 degrees W 1500 feet to stake, thence S 64 degrees E 400 feet to stake, thence N 26 degrees E 900 feet to corner of Barton property line approximately 251.5 feet west of Cathedral Manor, thence proceeding with Barton property line and existing City limit line N 15 degrees 30' E 758 feet , thence N 85 degrees E 252 feet,

thence N 28 degrees 30' E 570 feet, thence N 70 degrees W 197 feet east line of Barton Road, thence N 28 degrees E 150 feet, thence S 77 degrees W 40 feet across Barton Road, thence S 28 degrees W 400 feet thence S 56 1/2 degrees W 200 feet to the point of beginning.

This ordinance shall be in full force and effect upon its final passage and publication as required by law.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of said conflict.
