ORDINANCE NO. 4 - 01

AN ORDINANCE OF THE CITY OF BEREA, KENTUCKY, ANNEXING CERTAIN REAL PROPERTY LOCATED NEAR BEREA, MADISON COUNTY KENTUCKY.

WHEREAS, interest has been evidenced in annexing several tracts of land located to the north of the current corporate limits; and

WHEREAS, the City Council has determined that the tracts of land proposed to be annexed are adjacent and contiguous to the current corporate limits and which by reason of population density, use of the land, including subdivision of land, both existing and expected, the land proposed to be annexed is suitable for development for urban purposes, so that the corporate boundaries of the City should be extended to include this area; and

WHEREAS, the City wishes to be able to be in the position to extend certain municipal services to this area; and

WHEREAS, the tracts described herein are not already incorporated; and

WHEREAS, the owners of the property agree to the annexation;

NOW, THEREFORE, the City Council of the City of Berea, Kentucky, does ordain as follows:

SECTION I

That the City of Berea, Kentucky, pursuant to KRS 81A.420 and KRS 81A.412, hereby annexes and makes a part of the corporate area certain tracts of property described as follows:

THE MAP ATTACHED SETS OUT THE TRACTS OF PROPERTY ANNEXED HEREBY AND IS ADOPTED AS IF FULLY SET OUT HEREIN. THE DESCRIPTIONS CONTAINED IN THE DEEDS ARE INCORPORATED BY REFERENCE HEREIN. THE DEEDS AND MAP SET OUT THE PROPERTY ANNEXED BY THIS ORDINANCE.

SECTION II

Upon the enactment of this ordinance, the territory described in Section I is part of the City of Berea for all purposes.

SECTION III

Pursuant to previous agreement with the Madison Fiscal Court dated December 31st, 1997, whereby the City of Berea was granted authority to enact land use regulations outside of the corporate limits in an area which included the property annexed herein, and pursuant to the provisions of Ordinance No. 13-2000, enacted on the 17th day of October, 2000, the City Council of the City of Berea assigned zoning classifications to the properties annexed herein, so that pursuant to the provisions of KRS 100.209, each of the properties shall remain in the zoning classification previously assigned, provided that such classifications shall after the effective date hereof be referred to as the current City zoning classification most nearly similar to such existing classification, and further that properties which currently are classified Agricultural shall be included in the City's new Agriculture zoning classification.

SECTION IV

The City Clerk or any other officer having custody of official maps or records of the City is hereby directed to amend such maps or records to reflect the annexation provided for herein.

SECTION V
