**FINDINGS OF FACT, CONCLUSIONS OF LAW, AND
JUDGMENT DISSOLVING THE CITY OF BLAINE, KENTUCKY**

This matter having come before the Court for a status conference, and the Court being sufficiently advised, makes the following findings of fact and conclusions of law, and enters the following Judgment:

FINDINGS OF FACT

1. The City of Blaine, Kentucky ("Blaine") is a city of the sixth class located in Lawrence County.
2. Petitioner herein, Regina Jordan, is a bona fide resident of Blaine, with an address at 131 Cedar St., Blaine, KY 41124.
3. Blaine has not elected or appointed a mayor or any other city officer for over one year.
4. Blaine has not levied or collected any taxes for over one year.
5. By Order of this Court entered November 10, 2021, the Lawrence Circuit Clerk published a notice in the *Big Sandy News* informing the public of the Petition and fixing a deadline of December 10, 2021 to file a motion to intervene in this action. No such motions have been filed.
6. Blaine's assets consist of \$27,297.11 in cash being held by the Kentucky Department of Local Government.

7. Blaine has no liabilities that have been brought before the Court.

CONCLUSIONS OF LAW

Because Blaine has failed: (1) to elect or appoint a mayor or any other city officer and (2) to levy or collect any tax for over one year, it shall be dissolved pursuant to KRS 81.094.

JUDGMENT

1. The City of Blaine, Kentucky is hereby dissolved.
2. The assets of the City shall be distributed to the general fund of the Lawrence Fiscal Court. Should any additional assets be discovered after the date of this Order, those assets shall also be distributed to the general fund of the Lawrence Fiscal Court.
3. Within ten (10) days of entry hereof, the Clerk of this Court shall certify a copy of this Judgment to the Kentucky Secretary of State.
4. This is a final and appealable order, there being no just cause for delay.
