Dear Mr. Eckhoff:

I received your letter of July 13 along with a map indicating the present boundaries of the city of Blue Ridge Manor. You did not, however, indicate a date of incorporation for the city. Since our files contain no information at all about Blue Ridge Manor, it is important that we have this date and anything else that you can send us. A copy of the judgment of the Circuit Court incorporating the town would be most helpful. Until we receive some verification of incorporation, I cannot consider Blue Ridge Manor to be in compliance with KRS 81.045.

Since July 15 is the deadline for these reports, I hope that you will respond promptly. Otherwise, Blue Ridge Manor will not be eligible for any state road fund money.

If our office can assist you on this or any other matter, please do not hesitate to let me know.
