PETITION TO INCORPORATE CITY OF BONNIEVILLE

The Court having considered the pleadings and exhibits herein and it appearing that proper notice having been published as
required by law, and it further appearing that the petitioners
are entitled to the relief sought, it is therefore now ordered and
adjudged that the portion of the community of Bonnieville embraced
in the description hereinafter set out be and it is incorporated
as a City of the Sixth Class, and be and it is named Bonnieville,
same being located in Hart County, Kentucky.

It is further ordered and adjudged that the area incorporated and constituted the City of Bonnieville, and located in Hart County Kentucky, be and it is as follows:

BEGINNING at a point in the right-of-way west side of 31-W, thence south 84 and 5 \* west 677 feet to a marker on W.B. Reynolds. This line crossing LAN Rail Road main track at a point 800 feet south of mile post 65; thence south 5 55 east 2640 feet to a marker on W.B. Reynolds; thence north 84 5 \* ast 2640 feet to a marker; thence north 5 55 west 2640 feet to a marker; thence south 84 5 west 1963 feet to the beginning, containing 1/4 of one square mile-160 acres.

It is further ordered that the plat filed herein be drawn into this judgment and constituting a part thereof.

It is further ordered and adjudged that the following citizens and residents of the City of Bonnieville be and they are appointed and duly constituted as officers as their names and office designated appear of the City of Bonnieville, Kentucky to-wit:
