ORDINANCE ANNEXING APPROXIMATELY
232 ACRES CONTIGUOUS TO A WESTERN
BOUNDARY OF THE CITY IDENTIFIED AS
WELLS PROPERTY

ORDINANCE NO. BG80 - 42

WHEREAS, on the 26th day of February, 1980, the Board of Commissioners of the City of Bowling Green, Kentucky, enacted Ordinance No. BG80-25 proposing the annexation of the following described real estate into the City of Bowling Green in accordance with KRS 81.140, 81.100 and 81.110; and,

WHEREAS, said Ordinance No. BG80-25 has been properly published as required by law and more than thirty days elapsed since the enactment of said ordinance proposing said annexation and during this period no petition, complaint or suit has yet been filed in the Warren Circuit Court contesting or protesting the said proposed annexation;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Board of Commissioners of the City of Bowling Green, Kentucky, pursuant to KRS 81.140, 81.100 and 81.110 as follows:

(1) That the entire tract of real estate described in the attached "Description of proposed annexation" including approximately 232 acres which joins the western boundary of the City identified as Wells Property, shall be and is hereby annexed into the City of Bowling Green, Kentucky, and the boundary of the City is hereby extended so as to include and incorporate all of said real estate and area into the City of Bowling Green;

(2) That this ordinance shall be in full force and effect upon signature and recordation.

"Description of Proposed Annexation"

Area VI

Physical boundaries of this annexation shall embrace the following described territory: Beginning at a point on the eastern right-of-way of the Green River Parkway, said point being on the existing corporate limit line; thence with said right-of-way in a north-westerly direction, 4,850 feet, more or less, to a point on the existing corporate limit line; thence leaving said right-of-way and with the existing corporate limit line S 83° 40' E, 1,070 feet, more or less; thence with a property line of the Western Development Corporation S 08° 00' W, 1,300 feet, more or less; thence S 58° 00' E, 3,150 feet, more or less; thence from a point in the property line of said corporation and with the western property line of M.C. Hinton S 36° 32' W, 580 feet; thence with the line of said property S 53° 33' E, 1,384 feet, more or less to the center line of U.S. Highway 68; thence with the center line of said highway S 40° 00' W, approximately 800 feet; thence leaving the center line of said highway N 65° 00' W, 25 feet to a point on the northwest right-of-way of said highway; thence with the said right-of-way S 40° 00' W, 1,580 feet; thence leaving said right-of-way, N 57° 54' W, 2,145 feet to the point of beginning. Said physical boundaries containing 232.60 acres, more or less.
