
Dear Sir:

ORDINANCE NO. BG87 - 4

ORDINANCE ANNEXING 4.74 ACRES, A CERTAIN AREA
LOCATED AT 5301 SCOTTSVILLE ROAD AND CONTIGUOUS
TO EXISTING CITY LIMITS

WHEREAS, on the 18th day of November, 1986, the Board of Commissioners of the City of Bowling Green, Kentucky, enacted Ordinance No. BG86-56 proposing annexation of the following real estate into the City of Bowling Green at the request of the property owners and/or voters and in accordance with KRS 81A.410 and 81.420; and,


WHEREAS, said Ordinance No. BG86-56 has been properly published as required by law and more than Sixty (60) days has lapsed since the enactment and publication of said Ordinance proposing said annexation and during this period, no petition, complaint or suit has been filed in Warren Circuit Court contesting or protesting the proposed annexation of properties referred to herein.


NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky, pursuant to 81A.420(3) as follows:

1. That the entire tract of real estate containing approximately 4.74 acres on described in the attached description marked Exhibit "A" which is incorporated herein by reference as if copied in full, and contiguous to the existing boundaries of the City a certain area located at 5301 Scottsville Road, presently owned by James A. Martens, shall be and is hereby annexed into the City of Bowling Green, Kentucky, and the boundary of the City is hereby extended so as to include and incorporate all of said real estate and area into the City of Bowling Green.

2. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on April 7, 1987, and given final reading on April 21, 1987, and said Ordinance shall be in full force and effect upon signature, recordation and publication in full pursuant to KRS Chapter 424.

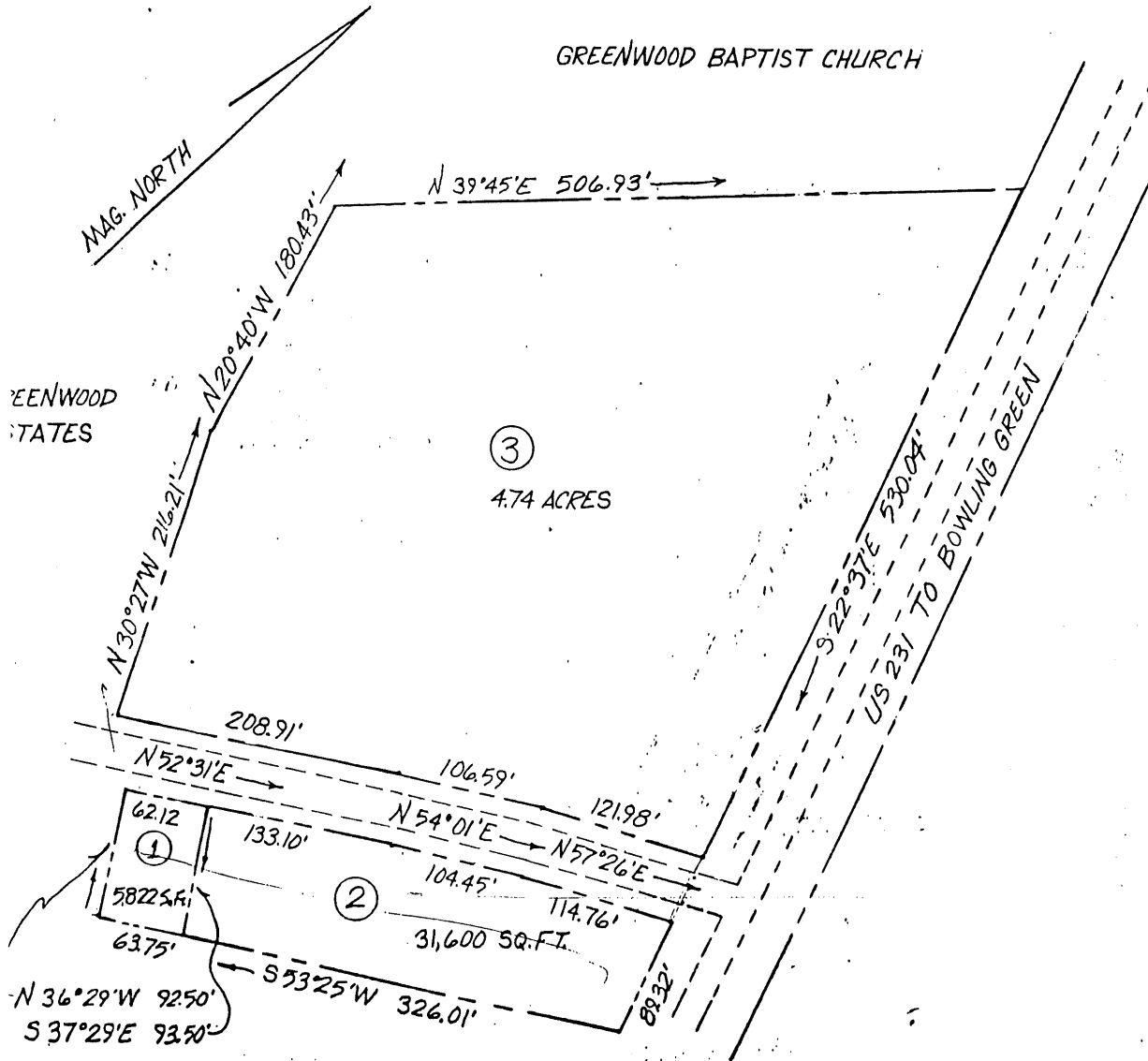
EXHIBIT "A"
