ORDINANCE NO. BG87 - 13

ORDINANCE ANNEXING 5.83 ACRES ON SMALLHOUSE ROAD AND CONTIGUOUS TO EXISTING CITY LIMITS

WHEREAS, on the 6th day of January, 1986, the Board of Commissioners of the City of Bowling Green, Kentucky, enacted Ordinance No. BG86-63 proposing annexation of the following real estate into the City of Bowling Green at the request of certain property owner and in accordance with KRS 81A.410 and 81.420; and,

WHEREAS, said Ordinance No. BG86-63 has been properly published as required by law and more than sixty (60) days has elapsed since the enactment and publication of said Ordinance proposing said annexation and during this period, no petition, complaint or suit has been filed in Warren Circuit Court contesting or protesting the proposed annexation of properties referred to herein.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky, pursuant to KRS 81A.420(3) as follows:

- 1. That the entire tract of real estate containing approximately 5.83 acres on described in the attached description marked Exhibit "A" which is incorporated herein by reference as if copied in full, and contiguous to the existing boundaries of the City and located on Smallhouse Road, shall be and is hereby annexed into the City of Bowling Green, Kentucky, and the boundary of the City is hereby extended so as to include and incorporate all of said real estate and area into the City of Bowling Green.
- 2. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on March 17, 1987, and given final reading on April 7, 1987, and said Ordinance shall be in full force and effect upon signature, recordation and publication in full pursuant to KRS Chapter 424.

EXHIBIT "A"

DESCRIPTION OF ANNEXATION OF THE WILLIAM T. WADE PROPERTY ON SMALLHOUSE ROAD

Beginning at a point in the Bowling Green, Kentucky, City Limits 225 feet north of the intersection of the centerlines of Smallhouse Road and Walnut Way, point common to the centerline of Smallhouse Road, thence with with said centerline in a northerly direction 350 feet; thence at a right angle in an easterly direction 725 feet to the northeastern corner of tract number 2 of the Mitchell Heights Subdivision of record in Plat Book 4, Page 12, on file in the Office of the Clerk of the Warren County Court, thence at a right angle in a southerly direction 350 feet to the southeastern corner of said tract; thence at a right angle and with the property line of said tract in a westerly direction 725 feet to the point of beginning, containing 5.83 acres more or less.
