ORDINANCE ANNEXING APPROXIMATELY 40 ACRES ON  
GREENWOOD WAY CONTIGUOUS TO THE CITY OF BOWLING  
GREEN, KENTUCKY, WITH A SOUTHWESTERN BOUNDARY  
AND IDENTIFIED AS THE CONVENTION COMMISSION/  
BRYANT PROPERTY

ORDINANCE NO. BG82 - 5

WHEREAS, on the 8th day of December, 1981, the Board of Commissioners of the City of Bowling Green, Kentucky, enacted Ordinance No. BG81-74 proposing the annexation of the following described real estate into the City of Bowling Green at the request of the property owner and in accordance with KRS 81A.410 and 81A.420; and,

WHEREAS, said Ordinance No. BG81-75 has been properly published as required by law and more than Sixty (60) days have elapsed since the enactment of said Ordinance proposing said annexation and during this period, no petition, complaint or suit has been filed in the Warren Circuit Court contesting or protesting the said proposed annexation.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky, pursuant to KRS 81A.420 (3) as follows:

(1) That the entire tract of real estate described in the attached "Description of Proposed Annexation" including approximately 40 acres on Greenwood Way identified as the Convention Commission/Bryant Property contiguous to the City with a Southwestern boundary, shall be and is hereby annexed into the City of Bowling Green, Kentucky, and the boundary of the City is hereby extended so as to include and incorporate all of said real estate and area into the City of Bowling Green.

(2) This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on February 9, 1982, and given final reading on February 16, 1982, and said Ordinance shall be in full force and

effect upon signature, recordation and publication in full pursuant  
to KRS Chapter 424.

W 142.07 feet; thence S 36 deg. 23 min. W 31.95 feet; thence S 36 deg. 9 min. W 71.04 feet; thence S 37 deg. 55 min. W 24.60 feet, thence S 33 deg. 48 min. W 675.09 feet; thence leaving said right of way N 62 deg. 08 min. W 542.67 feet to a fence post, said post being in the Interstate 65 Access Control fence line; thence with said fence N 24 deg. 21 min. E 777.58 feet; thence N 28 deg. 5 min. E 190.48 feet; thence N 22 deg. 20 min. E 300.37 feet; thence N 13 deg. 52 min. E 202.01 feet; thence N 22 deg. 21 min. E 665.30 feet; thence N 32 deg. 21 min. 47 sec. E 309.67 feet to an iron pin, point common with the existing City Limits S 54 deg. 20 min. W 1135 feet more or less to the point of beginning.
