## ORDINANCE NO. BG98 - 36

## ORDINANCE ANNEXING PROPERTY BY CONSENT

ORDINANCE ANNEXING THREE PARCELS OF PROPERTY LOCATED ON WILLIAM NATCHER PARKWAY AND MORGANTOWN ROAD PRESENTLY OWNED BY KENNETH J. ALLEN, LEON TARTER AND STONEHENGE CORPORATION WITH SAID TERRITORY BEING CONTIGUOUS TO EXISTING CITY LIMITS

WHEREAS, Kenneth J. Allen, Leon Tarter and Charles English, on behalf of Stonehenge Corporation, have requested and consented in writing to annexation into the City of Bowling Green pursuant to KRS 81A.412 of property located on William Natcher Parkway and Morgantown Road and identified as parcel numbers 028A-16, 028A-15 and 028A-13 on the Property Valuation Administrator's map; and,

WHEREAS, Kenneth J. Allen, Leon Tarter and Stonehenge Corporation are the owners on record of the land to be annexed; and,

WHEREAS, the City of Bowling Green wishes to annex this property being contiguous to existing city limits.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky, pursuant to KRS 81A.412 as follows:

1. That the three parcels of property, identified as parcel numbers 028A-16, 028A-15 and 028A-13 on the Property Valuation Administrator's map, which are contiguous to existing city limits, presently owned Kenneth J. Allen, Leon Tarter and Stonehenge Corporation, shall be and are hereby annexed into the City of Bowling Green, Kentucky, by consent of the owners, and the boundaries of the City are hereby extended so as to include and incorporate all of said real estate into the City of Bowling Green.

- 2. A copy of this Ordinance shall be forwarded to the Public Works Department, Engineering Division and it is hereby authorized and directed to make the necessary changes to the territorial limits of the City in Chapter One of the City of Bowling Green Code of Ordinances to reflect this annexation.
- 3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.


