ORDINANCE ANNEXING PROPERTY BY CONSENT

ORDINANCE ANNEXING ONE PARCEL OF PROPERTY LOCATED OFF VETERANS MEMORIAL BOULEVARD AND MORGANTOWN ROAD PRESENTLY OWNED BY STONEHENGE CORPORATION WITH SAID TERRITORY BEING CONTIGUOUS TO EXISTING CITY LIMITS

WHEREAS, Charles English, on behalf of Stonehenge Corporation, has requested and consented in writing to annexation into the City of Bowling Green pursuant to KRS 81A.412 of property located off Veterans Memorial Boulevard and Morgantown Road and identified as parcel number 040A-029 on the Property Valuation Administrator's map; and,

WHEREAS, Stonehenge Corporation is the owner on record of the land to be annexed; and,
WHEREAS, the City of Bowling Green wishes to annex this property being contiguous to existing city
limits.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky, pursuant to KRS 81A.412 as follows:

- 1. That the one parcel of property, identified as parcel number 040A-029 on the Property Valuation Administrator's map, which is contiguous to existing city limits, presently owned Stonehenge Corporation, shall be and is hereby annexed into the City of Bowling Green, Kentucky, by consent of the owner, and the boundaries of the City are hereby extended so as to include and incorporate all of said real estate into the City of Bowling Green.
- 2. A copy of this Ordinance shall be forwarded to the Public Works Department, Engineering Division and it is hereby authorized and directed to make the necessary changes to the territorial limits of the

City in Chapter One of the City of Bowling Green Code of Ordinances to reflect this annexation.

3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.



Beginning at a point in the city limits of Bowling Green, said point being in the south right-ofway of Morgantown Road (U.S. 231), said point being a corner of English (D.B. 203 PG. 464) and in the west property line of English (D.B. 504 PG. 296); thence with property line of English and English S 10° 22' 33" E 524.60' to a corner of Commonwealth of Kentucky (D.B. 729 PG. 564); thence with property line of English (D.B. 203 PG. 464) and Commonwealth of Kentucky S 10° 34' 10" E 313.16' to a corner common to Commonwealth of Kentucky and Cedar Grove Subdivision Section 8; thence with property line of said English property and said subdivision S 40° 38' 8" W 510.03'; thence N 49° 21' 52" W 62.98'; thence S 40° 00' 36" W 357.51' to a point common to English, Cedar Grove Subdivision Section 8, and Cedar Grove Subdivision Section 9; thence with property line of English and Cedar Grove Subdivision Section 9 N 49° 59' 24" W 102.04'; thence S 88° 25' 14" W 242.98' to a point common with English and Crutcher (D.B. 536 PG 792); thence with English and Crutcher property line N 10° 22' 16" E 1307.30' to a point in the south right of way of Morgantown Road (U.S. 231), said point being common to English and Crutcher; thence with south right-of-way of Morgantown Road (U.S. 231) N 81° 37' 31" E 181.15'; thence N 78° 47' 12" E 375.08' to point of beginning, containing 20.17 acres more or less.
