ORDINANCE ANNEXING PROPERTY

ORDINANCE ANNEXING UNINCORPORATED TERRITORY CONTAINING APPROXIMATELY 15.44 ACRES IN THE WHITESBORO SUBDIVISION IN THE VICINITY OF CAVE MILL ROAD AND SMALLHOUSE ROAD, WITH ALL SUCH TERRITORY BEING CONTIGUOUS TO EXISTING CITY LIMITS

WHEREAS, on the 20th day of May 2008, the Board of Commissioners of the City of Bowling Green, Kentucky enacted Ordinance No. BG2008-23 declaring the City's intent to annex into the City approximately 15.44 acres in the Whitesboro Subdivision in the vicinity of Cave Mill Road and Smallhouse Road pursuant to 81A.410 and 81A.420; and,

WHEREAS, said Ordinance No. BG2008-23 was properly published on May 23, 2008 as required by law, and more than sixty (60) days have lapsed since the enactment and publication of said Ordinance proposing said annexation and during this period, no petition or complaint has been filed in the Mayor's office nor has a suit been filed in Warren Circuit Court contesting or protesting the proposed annexation of property referred to herein.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

- 1. The territory containing approximately 15.44 acres, more or less, in the Whitesboro Subdivision in the vicinity of Cave Mill Road and Smallhouse Road, which territory is more particularly described on the attached map and incorporated herein by reference as if copied in full, is hereby armoved into the City limits.
- 2. A copy of this Ordinance shall be forwarded to Public Works Department, Engineering Division and it is hereby authorized and directed to make the necessary changes to the territorial limits of the City in Chapter One of the City of Bowling Green Code of Ordinances to reflect this annexation.
 - 3. The provisions of this Ordinance are hereby declared to the severable and, if any section,

phrase or provision shall, for any reason, be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.

- 4. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinances in conflict herewith are hereby repealed and the provisions shall, for any reason, be declared invalid, such declaration of invalidity shall not affect the remainder of this Ordinance.
- 5. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on August 5, 2008, and given final reading on August 19, 2008, and said Ordinance shall be in full force and effect upon signature, recordation and publication in summary pursuant to KRS Chapter 424.

Being a 10.12 acre tract of land located at the rights-of-way intersection of Smallhouse Road and Cave Mill Road in the City of Bowling Green and more particularly described by metes and bounds as follows:

Beginning at a point in the existing city limits of The City of Bowling Green and being in the north right-of-way line of Cave Mill Road said point being approximately 887 feet from the west right-of-way line of Smallhouse Road and corner common to Lots 14 and 15 Whitesboro Subdivision (Plat Book 3 Page 76); thence leaving the right of way line of Cave Mill Road and with the common line of said Lots 14 and 15 N 10 deg 03 min 22 sec E 400.00 feet to a point, said point located in the line of Tract "B" of aforesaid subdivision; thence leaving said common line and with the common line of aforesaid Tract "B" S 79 deg 56 deg 38 sec E 380.63 feet to a point, said point located in the line of Lot 5 of aforesaid subdivision; thence with the common line of said Tract "B" and said Lot 5 and continuing with Lot 4 of aforesaid subdivision N 05 deg 44 min 20 sec W 197.31 feet to a point, said point corner common to Lots 4 and 3 of aforesaid subdivision; thence leaving said Tract "B" and with the common line of said Lots 4 and 3 N 84 deg 15 min 41 sec E 396.85 feet to a point, said point located in the west right-of-way line of Smallhouse Road; thence leaving said Lot 3 and with said right-of-way and continuing with said Lot 4, then Lots 5 through 10 of aforesaid subdivision S 05 deg 57 min 05 sec E 701.72 feet to a point, corner common to aforesaid Lot 10: thence with said Lot 10 S 84 deg 02 min 55 sec W 20.00 feet to a point; thence S 03 deg 41 min 14 sec E 18.38 feet to a point, said point located in the north right-of-way line of Cave Mill Road; thence with said right-of-way and continuing with aforesaid Lot 10, then Lots 11 through 14 of aforesaid subdivision N 79 deg 56 min 38 sec W 887.44 feet to the point of beginning containing 10.12 acres and area to be defined for annexation purposed only as shown on The City of Bowling Green Public Works drawing number 28009 dated April 29, 2008.


Being a 5.32 acre tract of land located along the right-of-way of Cave Mill Road in the City of Bowling Green and more particularly described by metes and bounds as follows:
