

ORDINANCE ANNEXING PROPERTY BY CONSENCEMMONWEALTH OF KENTUCKY

ORDINANCE ANNEXING 26.24 ACRES OF PROPERTY LOCATED AT THE INTERSECTION OF MT. VICTOR LANE AND OLD LOVERS LANE WITH PROPERTY PRESENTLY OWNED BY BROWNING INVESTORS, LLLP AND O. L. AVERY, JR., AND SAID TERRITORY BEING CONTIGUOUS TO EXISTING CITY LIMITS

WHEREAS, pursuant to KRS 81A.412, the City of Bowling Green may annex any area which meets the requirements for annexation if the owner of record of the land to be annexed gives prior consent in writing; and,

WHEREAS, Browning Investors, LLLP, by and through David Browning, has requested and consented in writing to the annexation of 10.42 acres of private property located at the intersection of Mt. Victor Lane and Old Lovers Lane; and,

WHEREAS, O. L. Avery, Jr. has also requested and consented in writing to the annexation of 13.47 acres of private property located off Mt. Victor Lane; and,

WHEREAS, the City of Bowling Green hereby declares it desirable to annex these properties and approximately 2.35 acres of right-of-way as described in the attachments to this Ordinance; and,

WHEREAS, the proposed property to be annexed is adjacent or contiguous to the City, and the property is urban in character and suitable for development for urban purposes without unreasonable delay.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky pursuant to KRS 81A.412 as follows:

1. The property located at the intersection of Mt. Victor Lane and Old Lovers Lane identified on the attached map and further described in the attachments to this Ordinance containing a total of 26.24 acres, presently owned by Browning Investors, LLLP and O. L. Avery, Jr., all of which is

contiguous to existing City limits, shall be and is hereby annexed into the City of Bowling Green, Kentucky by consent of the owners, and the boundaries of the City are hereby extended so as to include and incorporate all of this real estate into the City of Bowling Green.

- 2. A copy of this Ordinance shall be forwarded to the Public Works Department, Planning and Design Division and it is hereby authorized and directed to make the necessary changes to the territorial limits of the City in Chapter One of the City of Bowling Green Code of Ordinances to reflect this annexation.
- 3. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.
- 4. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.

ANNEXATION Mt. VICTOR LANE BROWNING / AVERY

Being a 26.82 acre tract located at the intersection of Mt. Victor Lane and Old Lovers Lane in Warren County, Kentucky and adjacent to the existing city limits of the City of Bowling Green, Kentucky and being more particularly described as follows:

This description prepared by Robert S. Evans PLS# 3320, City Surveyor, Bowling Green Public Works. Sources for this description are Plat Book 40 Page 252 and Plat Book 40 Page 398 as recorded in the Warren County Court Clerk's office. This description is for annexation purposes only and not for the conveyance of property.

Beginning at a point in the north right-of-way of Old Ewing Ford Road said point is also in the south right-of-way of KY 234 (Cemetery Road) and being a corner common with Jr. Food Stores INC property (DB 810 PG 249) thence crossing Old Ewing Ford Road S 49°01'32" E, 50.95' to a point in the south right-of-way of Old Ewing Ford Road; thence with said right-of-way S 29°52'13" W, 189.68' to a point in the south right-of-way of Old Ewing Ford Road and the north right-of-way of Mt. Victor Lane; thence with Mt. Victor Lane S 57°11'11" E, 96.15' to a point; thence S 61°38'11" E, 106.03' to a point; thence S 61°38'12" E, 99.93' to a point; thence S 61°29'05" E, 71.09' to a point; thence S 61°33'51" E, 313.85' to a point in the east right-of-way of Interstate 65; thence crossing Mt. Victor Lane and with Interstate 65 S 12°24'05" W, 293.11' to a point; thence S 08°31'07" W, 68.51' to a point; thence S 08°12'24" W, 671.85' to a point; thence S 23°20'26" W, 223.16' to a point; thence S 21°58'41" W, 442.84' to a point; thence S 25°13'38" W, 4.52' to a point in east right-of-way of Interstate 65 and common with O.L. Avery (DB893 PG 256); thence leaving said right-of-way and with Avery N 48°40'04" W, 588.64' to a point common with Wallace Randolph (DB 896 PG 654); thence N 30°12′53" E, 431.30' to a point common with Jesse Stout (DB 458 PG 209); thence N 60°02'28" W, 196.45' to a point common with Gregory Vincent (DB 920 PG 239); thence with Vincent line N 31°11'35" E, 37.09' to a point; thence N 59°57'30" W, 173.85' to a point; thence N 32°05'24" E, 126.96' to a point; thence S 60°01'36" E, 20.00' to a point common with Bowling Green Praise and Worship Inc. (DB 998 PG 373); thence N 30°02'37" E, 207.57'to a point; thence with Bowling Green Praise and Worship Inc. line and crossing Old Lovers Lane N 58°03'28" W, 230.05' to a point in the north right-of-way of Old Lovers Lane; thence with said right-of-way with a curve to the left having a radius of 18511.96', a delta angle of 00°15'54", and an arc length of 85.66' to a point; thence with a curve to the left having a radius of 17830.20', a delta angle of 00°23'45", and an arc length of 123.19' to a point; thence N 28°28'10" E, 124.42' to a point; thence N 29°52'13" E, 272.64' to a point in the south right-of-way of Mt. Victor

Lane; thence crossing Mt. Victor Lane and with the north right-of-way of Old Ewing Ford Road N 29°52'13" E, 275.35' to the point of beginning containing 26.82 acres.

There is a 0.58 acre tract excepted from this description leaving 26.24 acres and more particularly described as follows:

Beginning at a point in the south right-of-way of Old Lovers Lane, said point is 273' +/-southwest of the intersection of Old Lovers Lane and Mt. Victor Lane; thence leaving said right-of-way S 58°06'09" E, 202.48' to a point; thence S 29°49'02" W, 125.54' to a point; thence N 57°58'36" W, 199.55' to a point in south right-of-way of Old Lovers Lane; thence with said right-of-way N 28°28'10" E, 125.30' to the point of beginning containing 0.58 acres, This tract is owned by MYP Properties (DB 1000 PG 535) Plat Book 23 Page 177 as recorded in the Warren County Court Clerk's Office.
