**CITY OF ST MATTHEWS**

**Ordinance No. 00-06**

**AN ORDINANCE RELATING TO ANNEXATION BY THE CITY OF ST. MATTHEWS OF THE ENTIRE AREA OF THE CITY OF BROAD FIELDS**

WHEREAS, KRS 81A.530 provides a means whereby a city of the sixth class may seek annexation and be annexed by an adjoining city of the third, fourth or fifth class, and

WHEREAS, the City Commission of the City of Broad Fields has adopted an ordinance in accordance with KRS 81A.530 to authorize a petition by its registered voters to be annexed to the City of St. Matthews, and

WHEREAS, the Jefferson County Clerk, through the Jefferson County Board of Elections, has certified the petition as containing the signatures of more than 51% of the number of registered voters in Broad Fields, and

WHEREAS, the certified petition has been presented to the City of St. Matthews, now therefore,

**BE IT ORDAINED BY THE CITY OF ST. MATTHEWS:**

1. The City Council of the City of St. Matthews hereby determines that it has a common boundary with the City of Broad Fields, and that the entire area of the City of Broad Fields can be better served by the City of St. Matthews, and should be annexed by the City of St. Matthews, and the City of Broad Fields dissolved as so approved in accordance with KRS 81A.530.

2. The annexation is hereby approved and the entire area of the City of Broad Fields is hereby annexed (merged) with the City of St. Matthews, and in accordance with the ordinance adopted by the City of Broad Fields:

a. All assets and liabilities of the City of Broad Fields shall pass to and become the assets and liabilities of the City of St. Matthews;

b. All taxes or revenues from the city of Broad Fields shall thereafter belong to the City of St. Matthews;

c. The zoning classification on all land within the City of Broad Fields shall remain unchanged until changed by the City of St. Matthews in accordance with KRS Chapter 100:

d. The annexation shall become effective as of July 1, 2000.

3. The City of Broad Fields shall be dissolved effective with the effective date of this ordinance.

4. All assets of the city of Broad Fields existing on the date of annexation shall become the property of the City of St. Matthews. Any indebtedness for which Broad Fields is liable on the date of annexation shall be assumed by the City of St. Matthews, so that after annexation the burden of taxation shall be uniform throughout the area of the two (2) cities, now one city.

5. This ordinance shall become effective on July 1, 2000.

Introduced and first reading by the City Council of the City of St. Matthews on this 13th day

of June, 2000. Passed and approved on this 27th day of June, 2000.
