## RESOLUTION 2011-005

A RESOLUTION ADOPTING AND CLARIFYING A MODERN AND ACCURATE LEGAL DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY ORDINANCES, 110.1, 110.2 AND 110.3.

WHEREAS, the City of Burnside has enacted numerous ordinances annexing property into the corporate limits of the City of Burnside; and

WHEREAS, each individual annexation contains a prior survey of prepared by now unknown individual, and further references documentation that is no longer in existence; and

WHEREAS, the City wishes to provide a modern, accurate, easily identifiable legal description reflecting bearings and coordinates based upon the state plane coordinate system, including relevant GPS and GIS data, same having been certified by a professional land surveyor for each prior annexation; and

WHEREAS, the City wishes to comply with the requirements of Amended KRS 81A.470 effective July 13, 2004; and

WHEREAS, the City does not intend to amend or replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt a modern and accurate legal description of territory previously annexed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNSIDE, KENTUCKY:

That Ordinances 110.1, 110.2 and 110.3 containing new surveys and plats as prepared by Anthony G. Thompson, Licensed Professional surveyor No. 3630 restate. but do not change or alter, the boundaries of the City of Burnside as the boundaries existed as of July 15, 1981, but simply clarify such boundaries as they existed as of July 15, 1981.
