## ORDINANCE NO. 90-18

ORDINANCE ANNEXING CERTAIN UNINCORPORATED TERRITORY INTO THE CITY LIMITS OF THE CITY OF CALVERT CITY LOCATED ADJACENT TO THE CALVERT CITY INDUSTRIAL COMPLEX

WHEREAS an ordinance stating the intention of the City to annex the referenced real property was passed by the City Council at the first reading on the 11th day of June, 1990; and

WHEREAS an ordinance stating the intention of the City to annex the referenced real property was passed by the City Council of the City of Calvert City, Kentucky at the second reading on the 9th day of July, 1990; and

WHEREAS the aforesaid ordinance stating the intention of the City to annex the referenced real property was made effective by publication pursuant to KRS Chapter 424 on the 11th day of July, 1990; and

WHEREAS sixty (60) days have passed since the enactment of the aforesaid ordinance of intent and no petition meeting the requirements of KRS 81A.420 (2) in opposition to the annexation has been received by the mayor;

BE IT ORDAINED BY THE CITY OF CALVERT CITY, KENTUCKY that the following described property is hereby annexed, added to, taken in and made a part of the corporate limits of the City of Calvert City, Marshall County, Kentucky, to wit:

Beginning at the northwest corner of the present corporate limits of Calvert City, said point being the intersection of the west boundary of North Star Steel extended with the Tennessee River; thence, with the present corporate limits of Calvert City generally described as follows: in a southeasterly direction with said North Star Steel property line projected to the point of intersection with the centerline of KY 1523; thence, in a northeasterly direction with the centerline of KY 1523 to the west right of way line of the Paducah & Louisville Railroad; thence, in a southerly direction with said west right of way line of the Paducah & Louisville Railroad to the south line of Air Products Inc. extended; thence, in an easterly direction with the south line of Air Products Inc., and its extension, to the east boundary of said property, same being the west right of way line of Alabama Street NW; thence, in a northerly direction with the

east boundary of Air Products Inc., same being the west right of way line of Alabama Street to the intersection of said line with a westerly projection of the north boundary of property formerly owned by Jesse and Velda Moss (now owned by Air Products, Inc.); thence, in an easterly direction with said Moss line and its projection, crossing Alabama Street NW and KY 95, to the east boundary of property now owned by Jesse and Velda Moss; thence, in a southerly direction with said Moss east line to the north right of way line of KY 282; thence, in a westerly direction with said north right of way of KY 282 to the centerline of KY 95; thence, in a southerly direction along the centerline of KY 95 to the centerline of Cypress Creek; thence, in a westerly direction with the meanders of Cypress Creek to the centerline of Alabama Street NW; thence, in a southerly direction along the centerline of Alabama Street NW to the north line of the Paducah & Louisville Railway; thence, in a westerly direction with the north right of way line of Paducah & Louisville Railroad to the intersection of said right of way line with the centerline of an unnamed road, said point being a corner of the present corporate limits; thence, leaving the present corporate boundary and continuing with the north right of way line of the Paducah & Louisville Railroad to the southwest corner of property owned by Purlanco, said point being approximately 0.7 miles west of KY 1523; thence, in a northerly direction with the west property line of Purlanco to the centerline of Cypress Creek, same being a north property line of Purlanco; thence, in a northeasterly direction with said Cypress Creek centerline to the intersection of the south property line of LWD Land Company; thence, with the LWD Land Company south line in a westerly direction to southeast corner of the JASMAT property; thence, continuing in a westerly direction with the JASMAT south property line to the southwest corner of said property; thence, in northwesterly direction with the JASMAT west property line and its extension to the north right of way of the Little Cypress-Sharpe (Coke Plant) Road, said point being the southwest corner of property owned by David Reed; thence, continuing in a northwesterly direction with the Reed west line to the Tennessee River; thence, in an easterly direction with the Tennessee River to the point of beginning.

There is excepted from the above-described property, all road rights of way owned by the Commonwealth of Kentucky, County of Marshall County, Kentucky, and the United States of America, and those roadways are not a part of the property annexed.

Upon the passing of this ordinance and publication of same in accordance with KRS Chapter 424, the above described property will be deemed annexed into the corporate limits of the City of Calvert City, Kentucky.
