AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED TERRITORY OWNED BY TONY A. CAMPBELL AND KATHERINE B. CAMPBELL LYING ADJACENT TO THE CITY'S BOUNDARY

WHEREAS, Tony A. Campbell and Katherine B. Campbell, being the owners of all of the land lying in the territory proposed to be annexed, have consented in writing to the proposed annexation pursuant to KRS 81 A.412; and,

WHEREAS the Calvert City Planning Commission has recommended to the City Council the annexation of the proposed territory and the zoning of the annexed territory as R-1; and,

WHEREAS, the City Council has determined the proposed annexation to be in the best interests of the City, and further has determined that the appropriate zoning designation for the annexed area is R-1.


