ORDINANCE NO. 2004-10

AN ORDINANCE ANNEXING AN AREA AT THE WEST END OF PRINCESS JENNIFER DRIVE LYING ADJACENT TO THE EXISTING CORPORATE LIMITS OF THE CITY OF CALVERT CITY, KENTUCKY

WHEREAS, William Bruce Lyles and wife, Wendy Lyles, being the owners of all of the land lying in the territory proposed to be annexed, have consented in writing to the proposed annexation pursuant to KRS81A.412; and,

WHEREAS, the Calvert City Planning Commission has complied with the notice and public hearing provisions of KRS100.209 and has recommended to the City Council the annexation of the proposed territory and the zoning of the annexed territory as R-1; and,

WHEREAS, the City Council has determined the proposed annexation to be in the best interest of the City, and further has determined that the appropriate zoning designation for the annexed area is R-1.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF CALVERT CITY, COMMONWEALTH OF KENTUCKY, that the following described property be annexed into the City of Calvert City, Kentucky:

Being a 2.300 acre tract of land situated at the west end of Princess Jennifer Drive, lying adjacent to the existing Corporate Limits of Calvert City, Ky., generally located approximately 1130 feet west of Ky. Hwy. 95, and being more particularly described as follows:

Unless stated otherwise, any monument referred to herein as a "Pipe and Cap" is a set 3/4" diameter schedule 40, steel pipe, eighteen (18") in length, with an orange plastic cap stamped "J.E.S. L.S. #2236". All bearings shown herein are referred to the magnetic north meridian as observed September 02, 2004;

Beginning at the southeast corner of the herein described tract, said point being in the existing Corporate Limits line to the City of Calvert City, KY. said beginning point being in the south line of Princess Jennifer Drive and also being the northwest corner of Lot no. 49, of Kingswood Subdivision as shown on a plat of record on slide no. 355, Marshall County Court Clerk's Office, said beginning point being in the east boundary line of the Lonnie A. & Charlene Smith property (deed book 108, page 32);

Thence, along the south right-of-way line of the proposed extension to Princess Jennifer Drive, as follows, N 87 deg. 09' 23" W - 305.00 feet to the beginning of a cul-d-sac situated at the west end of said extension;

Thence, with the curve of said cul-d-sac having a radius of 50 feet, an arc length of 157.08 feet, subtended by a straight chord bearing of N 2 deg. 42' 49" E – 100.00 feet to a point on the north side of said cul-d-sac;

Thence, N 2 deg. 42' 49" E-213.79 feet to a point in the south boundary line of Royal Park Estates Subdivision, Phase II, said point being the northwest corner of the herein described tract;

Thence, S 87 deg. 02' 52" E-308.55 feet along the south boundary line of said subdivision, to a point in the existing Corporate Limits line of Calvert City, Ky.

Thence, S 3 deg. 21' 47" W - 313.22 feet along said Corporate Limits line, back to the point of beginning.

Containing 2.300 acres according to a survey by James E. Stevenson, Professional Licensed Land Surveyor No. 2236, with J.E. Stevenson & Associates on September 02, 2004.

BE IT FURTHER ORDAINED that the above-described property is hereby designated as a R-1 zoning district, in accordance with the revised zoning map of the City of Calvert City, attached hereto and made a part hereof.
