ORDINANCE No. 92-007

AN ORDINANCE ANNEXING INTO THE CORPORATE BOUNDARIES
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY,
CERTAIN TRACTS OR PARCELS OF LAND LYING IN TAYLOR COUNTY
AND BELONGING TO THOMAS M. MURPHY AND MARGARET F. MURPHY.

WHEREAS, the City of Campbellsville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 2nd day of March, 1992; and the 16th day of March, 1992.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area to be annexed is urban in character and that prior to the annexation it was an unincorporated territory.

The land hereby annexed is described as follows:

Certain tracts or parcels of land lying and being in Campbellsville, Taylor County, Kentucky, and being described as follows:

VACANT LOT - Beginning at an iron pin on the south side of West Main Street, corner of the Mrs. Charlie L. McMahan property (Deed Book 71, 202) thence with the lines of said McMahan property as follows: South 09 degrees 28 minutes East 160.0 feet; North 82 degrees 11 minutes East 50.0 feet to a post; thence South 08 degrees 52 minutes West 50.6 feet to an iron pin, corner of the Paul Mills property (Deed Book 169, page 572); thence with eh line of said Mills property South 64 degrees 36 minutes West 200.3 feet to an iron pin being a new division corner in the Kingsbury property (Deed Book 142, page 245); thence with a new division line in said Kingsbury property North 19 degrees 38 minutes West 239.6 feet to an iron pin on the south side of West Main Street, said iron pin being a new division corner in said Kingsbury property; thence with the south side of said West Main Street North 72 degrees 26 minutes E 202.8 feet to the beginning containing 1.0 acre.

This property is hereby zoned B-4.

This Ordinance was introduced and given a first reading and passage at a regular meeting of the City Council held on the 6th day of April, 1992; it received its second reading, passage and became effective at a regular meeting of the City Council held on the 20th day of April, 1992.
