AN ORDINANCE ANNEXING INTO THE  
CORPORATE BOUNDARIES OF THE CITY  
OF CAMPBELLSVILLE, KENTUCKY CER-  
TAIN PROPERTIES LYING IN SOUTH  
CAMPBELLSVILLE.

WHEREAS, the City of Campbellsville has heretofore pro-  
posed an Ordinance to annex the within described area, said  
Ordinance being read on the 17th day of May, 1982, and the 7th  
day of June, 1982, and thereafter said proposed Ordinance annex-  
ing the within described property having been advertised in toto  
in the Central Kentucky News Journal on the 14th day of June,  
1982.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the  
Common Council of the City of Campbellsville, Kentucky, does  
hereby annex into the corporate boundaries of the City of Camp-  
bellsville, Kentucky, the hereinafter described properties, and  
further the Common Council does hereby declare that the annexa-  
tion is desirable to the needs of the City of Campbellsville,  
Kentucky; does further state that the area to be annexed is urban  
in character and that prior to the annexation it was an unin-  
corporated territory.

The land hereby annexed is described as follows:

Beginning at a point on the southeast side of  
Roland Street in the present city limits line;  
thence with the southeast side of said Roland  
Street S 35 W 1042 ft. to a point on the south-  
east side of said Roland Street; thence crossing  
said Roland Street and then with the line of the  
R. H. Dudgeon property and then crossing Stone  
Quarry Road and then crossing the David Johnson  
property N 53-30 W 600 ft. to a point on said  
Johnson property; thence crossing said Johnson  
property and then with the line of the Clifton  
Sallee property N 35-30 E 782 ft. to a corner  
of said Sallee property; thence with the lines  
of said Sallee property as follows: S 56 E 25  
ft.; N 35-30 E 200 ft.; N 56 W 180 ft.; S 86-15  
W 200 ft.; N 56 W 175 ft. to a point on the  
southeast side of Howard Street, corner of said  
Sallee property; thence with the southeast side  
of said Howard Street S 35 W 470 ft. to a point  
in the line of said David Johnson property,  
corner of said Sallee property; thence with the  
line of said Johnson property N 34 W 120 ft. to  
a point in the line of said Johnson property,  
corner of the Arnold Denton property; thence  
with the line of said Denton property N 35 E  
690 ft. to a point in the line of said Denton  
property, said point being in the existing city  
limits line; thence with the existing city limits  
line S 54-15 E 1038 ft. to the beginning contain-  
ing 17.1 acres more or less.

This Ordinance was introduced and given a first reading and passage at a regular meeting of the Common Council held on the 4th day of October, 1982; it received its second reading, passage and became effective at the next regular meeting of the Common Council held on the 18th day of October, 1982.


