

ORDINANCE NO. 07-11

**AN ORDINANCE ANNEXING INTO THE BOUNDARIES
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, CERTAIN
TRACTS OR PARCELS OF LAND LYING IN TAYLOR COUNTY,
COMMONLY REFERRED TO AS THE FORMER
FRUIT OF THE LOOM PROPERTY**

WHEREAS, the City of Campbellsville has heretofore passed a proposed Ordinance to annex the within described area, said Ordinance being read on the 2 day of April, 2007, and the 7 day of May, 2007;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the boundaries of the City of Campbellsville, Kentucky, the hereinafter described property; and further, the City Council does hereby declare that the annexation meets the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area now being annexed is urban in character and that prior to the annexation it was an unincorporated territory.

Property Description

Parcels 1 and 2

The two (2) parcels depicted on the attached map. The annexed area is depicted in purple/lavender hatching and is generally referred to or known as the former Fruit of the Loom Property, identified as those two parcels near Greensburg Road, W. Main Street and New Columbia Road.

The aforementioned street names DO NOT constitute actual legal descriptions, nor are they intended to define and currently depict the properties. Instead, the street names are provided to indicate general areas which are more precisely reflected on the attached plat and description. The actual legal description will be affixed hereto.

The property hereby annexed shall be zoned B - 4.




