

ORDINANCE NO. 01-00 08

AN ORDINANCE ANNEXING INTO THE CORPORATE BOUNDARIES OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, A CERTAIN TRACT OR PARCEL OF LAND LYING IN TAYLOR COUNTY AND BELONGING TO SUPERIOR MANUFACTURING, INC.

Whereas the City of Campbellsville has heretofore received the request for annexation by the owner of the property more particularly described below, thus dispensing with the necessity of an Ordinance proposing annexation;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area being annexed is urban in character and that prior to the annexation it was an unincorporated territory.

The land hereby annexed is described as follows:

Being Tract I, as described on a plat which is of record in Plat Book 4, Page 94, in the Office of the Taylor County Court Clerk.

Being a portion of the property conveyed to Union Underwear Company, Inc. by Thomas A. Collins and wife, Norma B. Collins, by a deed dated July 23, 1985 of record in Deed Book 155, Page 43 in the Taylor County Court Clerk's Office and being a portion of the property conveyed to Union Underwear Company, Inc. by Union Underwear Company, Inc., a New York corporation, by deed dated August 31, 1995 and recorded on September 7, 1995 in Deed Book 75, Page 601 in the Taylor County Court Clerk's Office.

Note: Union Underwear Company, Inc., a Massachusetts corporation, was merged into Philread Underwear Company, Inc., a New York corporation, by a Certificate of Consolidation changing its name to Union Underwear Company, Inc., continuing as a New York corporation.


Note: The original Union Underwear Company, Inc., a New York corporation, was a different corporation from the present Union Underwear Company, Inc., of New York and no longer exists as Union Underwear Company, Inc.


