AN ORDINANCE ANNEXING A CERTAIN TRACT OF LAND BELONGING TO MEDCO CENTER, INC., AND BILLY PARRISH LOCATED ON OLD GREENSBURG ROAD AND LYING ADJACENT TO THE CITY LIMITS OF CAMPBELLSVILLE, KENTUCKY.

WHEREAS, MEDCO CENTER, INC. and BILLY PARRISH have made application to the Planning & Zoning Commission of the City of Campbellsville, Kentucky; and

WHEREAS, the Planning & Zoning Commission, pursuant to KRS Chapter 100, held a public meeting on the question of annexation and zoning of the hereinafter described land; and

WHEREAS, the Planning & Zoning Commission has formally recommended to the City Council that said land be annexed and zoned B-4;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, AS FOLLOWS:

That that land of Medco Center, Inc., and Billy Parrish described as follows:

Beginning at a point on Old Greensburg Road corner of Billy Parrish N  $1\frac{1}{2}$  E 60 ft. to a stake thence a division line in the lands of Billy Parrish N  $88\frac{1}{2}$  E 520 ft. to a point in the line of Medco Center, Inc., thence with the line of Medco Center, Inc., S  $1\frac{1}{2}$  E 330 ft. to a stake; thence N  $88\frac{1}{2}$  E 350 ft. to a stake; thence N  $1\frac{1}{2}$  W 373 $\frac{1}{2}$  ft. to a stake corner Old Greensburg Road, thence with Old Greensburg Road and with the line of Medco and Billy Parrish S  $88\frac{1}{2}$  W 870 ft. to the point of beginning.

be, and hereby is, annexed into and made a part of the City of Campbellsville, Kentucky; and further, that same be, and hereby is, zoned B-4, under and by virtue of the terms of the Zoning Ordinance of the City of Campbellsville, Kentucky.

This Ordinance was introduced and given first reading and passage at a meeting of the City Council held on the 17<sup>th</sup> day of FEBRUARY, 1986; it received its second reading, passage and became effective at the next regular meeting of the City Council held on the 3<sup>rd</sup> day of MARCH, 1986.




