

AN ORDINANCE ANNEXING INTO THE
CORPORATE BOUNDARIES OF THE CITY
OF CAMPBELLVILLE, KENTUCKY, CER-
PROPERTIES LYING BETWEEN FOREST
HILLS SUBDIVISION AND HARDING
CEMETERY ROAD.

WHEREAS, the City of Campbellville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 18th day of October, 1982, and the 1st day of November, 1982, and thereafter said proposed Ordinance annexing the within described property having been advertised in toto in the Central Kentucky News Journal on the 8th day of November, 1982.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF CAMPBELLVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the Common Council of the City of Campbellville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellville, Kentucky, the hereinafter described properties, and further the Common Council does hereby declare that the annexation is desirable to the needs of the City of Campbellville, Kentucky; does further state that the area to be annexed is urban in character and that prior to the annexation it was an unincorporated territory.

The land hereby annexed is described on Sechedule A hereunto annexed.

This Ordinance was introduced and given a first reading and passage at a regular meeting of the Common Council held on the 17th day of JAN, 1983; it received its second reading, passage and became effective at a regular meeting of the Common Council held on the 7th day of Feb., 1983.

SCHEDULE A

The land to be annexed is described as follows:

TRACT NO. 1:

Beginning at a post along the south side of the Jack Pike Road, corner to Audrey Blakeman's 5.0 acre tract; thence with the 5.0 acres tract S 3-15 W 760' to a post; thence N 69-30 E 315' to a post corner to Preston Pyles 8.67 acre tract; thence with Pyles line N 69-30 E 105' to a post; thence S 3-15 W 375' to a post; thence S 42-15 E 170' to an elm; thence S 61-15 E 200' to the center of the creek, C. G. Collins line; thence with Collins Line and down the creek S 5-30 W 120', S 23-30 E 127', S 49-45 E 170' and S 5 E 50' to a large sycamore on the west bank of the creek; thence N 68-45 E 55' to a steel pin in a drain, along the west side of the Campbellsville-Saloma Road [KY527]; thence with the Road S 25-30 E 110' to a point, corner to Skaggs; thence with Skaggs then Blevins & Gorin Land S 52 W 2265 to a hickory; thence N 74-30 W 889' to an oak & ash; thence N 19 W 356' to a post; thence N 71 E 1178' to a post; thence N 17-15 W 1185' to a post, corner to Sapps's 2.14 acre tract; thence with Sapp's tract N 72-30 E 109' to a post; thence N 20 W 504' to a steel rod along the south side of the Jack Pike Road; thence with the Road N 63 E 186' and N 69-30 E 951' more or less to the beginning. This tract contains 85.7 acres.

Beginning at a post at the southwest corner of Blevins & Gorins' 40 acres tract; thence a new division line in the land of Wade S 17-15 E 727' to a steel rod in the old line; thence with Blevins & Gorin's line S 52 W 475' to a hickory; thence N 74-30 W 889' to an oak & ash; thence N 19 W 356' to a post, corner to Blevins & Gorin's 40 acre tract; thence with same N 71 E 1178 more or less to the beginning. This tract contains 18.6 acres.

TRACT NO. 2:

Beginning at a large white oak tree along the North side of Jack Pike Road, corner to Harvey Gore's 22 acre tract; thence with Gore's line N 10 W 1835' to a post in Jim Pikes' line; thence with same N 70-30 E 691' to a steel rod, corner to Jerry Williams 7.75 acre tract; thence with same S 17-15 E 1629 to a pole along the road; thence with the road S 61 W W 150' and S 50-30 W 113' to a post; thence S 45 W 257' to a post, corner to the Harding-Campbell Cemetery; thence with the cemetery N 2-30 W 114' to a stone; thence S 81 W 91.5' to a stone; thence S 3 E 142' to a post; thence S 64-45' W 349' more or less to the beginning. This tract contains 32.3 acres.


TRACT NO. 3:

Beginning at a steel rod at the northeast corner of Lot 104 Section "D" Forest Hills Sub-division; thence with Lot 104 and 103 S 18 degree-19' E 350' to a point; thence a division line in the land of Blevins & Gorin N 71 E 82' to a black oak & gum corner to Otha & Barry Blevins land and Blevins & Gorin Twin Creek farm; thence with Otha & Barry Blevins N 19 W 356' to a post; thence S 66-15 W 77.2' more or less to the beginning. This tract contains 0.64 acres.
