AN ORDINANCE ANNEXING INTO THE CORPORATE BOUNDARIES OF THE CITY OF CAMPBELLSVILLE, KENTUCKY CERTAIN PROPERTIES LYING ADJACENT TO THE PRESENT BOUNDARIES OF THE CITY OF CAMPBELLSVILLE AND BEING FURTHER IDENTIFIED AS LOTS 73, 73A, 74 AND 74A OF THE FOREST HILLS SUBDIVISION AS SHOWN BY PLATS RECORDED IN PLAT BOOK 1, AT PAGES 107 AND 136.

WHEREAS, the City of Campbellsville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 18th day of May, 1981, and the 1st day of June, 1981, and thereafter said proposed Ordinance annexing the within described property having been advertised in toto in the Central Kentucky News Journal on the 4th day of June, 1981.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the Common Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described properties, and further the Common Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; does further state that the area to be annexed is urban in character and that prior to the annexation it was an unincorporated territory.

The land hereby annexed is described as follows:

Lots 73, 73A, 74 and 74A of the Forest Hills Subdivision, Sections C and D, as found of record in Plat Book 1, page 107 and page 136.

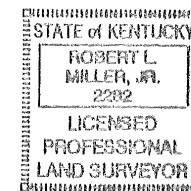
The bearings have been rotated to match existing Ordinance No. 91-02.

This plat is not a boundary survey and is not to be used for land transfer. This plat is for annexation purposes only.

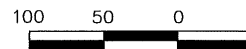
