RESOLUTION 10-35

A RESOLUTION ADOPTING A MODERN AND ACCURATE LEGAL DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY ORDINANCE

WHEREAS, the City of Campbellsville has enacted numerous ordinances annexing property into the corporate limits of the City of Campbellsville; and

WHEREAS, each individual annexation contains a prior survey oft prepared by now unknown individual, and further references documentation that is no longer in existence; and

WHEREAS, the City wishes to provide a modern, accurate, easily identifiable legal description reflecting bearings and coordinates based upon the state plane coordinate system, including relevant GPS and GIS data, same having been certified by a professional land surveyor for each prior annexation; and

WHEREAS, the City wishes to comply with the requirements of Amended KRS 81A.40 effective July 13, 2004, and

WHEREAS, the City does not intend to amend or replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt a modern and accurate legal description of territory previously annexed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY:

SECTION 1. That the City Council of the City of Campbellsville hereby adopts the following legal description, and a plat attached hereto as prepared by Robert L.Miller Jr, Licensed Professional Land Surveyor No. 2282 by new survey as an accurate depiction of the property previously annexed into the corporate city limits of the City of Campbellsville by Ordinance #96-4, dated July 1st, 1996, a copy of which is attached hereto as Exhibit "2", and hereby adopts said new legal description and plat as the official legal description and plat to be adopted by the City for all purposes when referencing this prior annexation.

ANNEXATION DESCRIPTION FOR CITY OF CAMPBELLSVILLE ORDINANCE NO. 96-4

A certain tract of land located on the east side of Greenhill Drive, formerly Goff Court, near the west limits of Campbellsville, Taylor County, Kentucky, and being Lot 7of the Goff Court Addition and being more particularly described as follows:

Beginning at a point on the east side of Greenhill Drive, formerly Goff Court, said point being located approximately 300 feet south of the intersection of Greenhill Drive and West Main Street, and corner of Lot 6 of the Goff Court Addition as recorded in Deed Book 47, Page 612; thence with the line of said Lot 6 North 74 degrees 45 minutes 33 seconds East 150.00 feet to a point in the existing City of Campbellsville boundary line, corner of said Lot 6; thence with said existing City boundary line South 12 degrees 46 minutes 23 seconds East 75.00 feet to a point in said City boundary line, corner of Lot 8; thence with the line of said Lot 8 South 74 degrees 45 minutes 33 seconds West 150.00 feet to a point on the east side of said Greenhill Drive, corner of said Lot 8; thence with the east side of said Greenhill Drive North 12 degrees 46 minutes 24 seconds West 75.00 feet to the beginning containing 0.25 acre.






